

Nominations Needed for New PSAI Sani Award



The intent of the Sani Award is to create a tool whereby PSAI Member companies have an avenue to recognize extraordinary employee contributions to the professionalism and success of the member company, and the Association, outside of the Andy Gump and Service Tech awards.

This award will not require a vote by any group or committee. It is up to the nominating member company to determine the nominee's eligibility.

Criteria for Nominee:

1. Service in any capacity with an Operator or Associate PSAI Member company
2. Minimum 10 years of industry experience
3. Nominee must be currently employed by the nominating company, have recently retired or be deceased since the previous year's award ceremony
4. Nominee must be a non-shareholder

Submission Requirements:

1. Criteria for Nominee satisfied
2. Submittal form completed
3. Short biography on nominee
4. Signed release form for publication permission

Guidelines for the Company Submitting a Nomination:

- Applications submitted after the deadline date will not be considered.
- The company must be a PSAI Member company in good standing to participate.
- One submission per company, per year.

Award and Personal Benefits:

Each year, the Distinguished Service Recognition recipients will be recognized at the PSAI Convention & Trade Show in San Antonio, Texas. They will be awarded a certificate and a lapel pin. In addition, they will be permanently highlighted on the PSAI.org web site under the Awards section.

Nominations

The PSAI will accept nominations from companies wishing to recognize an unlimited number of former employees (who meet the criteria outlined above) for contributions to the foundation of the industry. The 2011 Sani Award recipients will provide credibility for the Distinguished Service Recognition, while recognizing a cross section of early industry pioneers. Promotion of this will be important in kick-starting the Sani Awards, and the future nominating process.
